

Office of Human Rights Youth Human Rights Ambassador Program 2024 – 2025 APPLICATION



About:

The DC Office of Human Rights (OHR) has a unique opportunity for DC high school students to serve as Youth Human Rights Ambassadors. The 2024-2025 Youth Human Rights Ambassador cohort will work alongside OHR staff and will have a unique opportunity to be actively involved in and learn about human rights in the local government and having their voices heard about issues affecting DC youth. These individuals will be tasked with the following:

- Discuss and understand laws, rights and issues that affect youth while learning the tools on how to present and promote dialogue to other youth and adults throughout all eight wards.
- Create and implement programming with the goal of engaging and educating District youth and residents throughout all eight wards inspired by the DC Human Rights Act of 1977, civil rights laws, and other issues that may be of concern to DC youth. This programming will be designed by the cohort, with guidance from OHR and can take many shapes (*e.g.*, panel or community discussions, social media campaigns, etc) – make it your project!

Eligibility Requirements:

To serve as a Youth Human Rights Ambassador, youth must meet the following requirements:

- Must be enrolled in a District of Columbia high school. Student must be a rising 10th, 11th, or 12th grade student.
- Able to attend Youth Human Rights Ambassador training (date/time TBA)
- Able to attend Youth Human Rights Ambassador meetings 1-2 times a month.
 - Meetings are held on Thursdays from 5:00pm – 6:30pm at the Metropolitan Square Building, 655 15th Street, NW, Washington, DC 20005
- Attend or participate in at least two OHR sponsored events.
- Contribute to the cohort's projects and programming.

What we're looking for:

- Passionate and motivated by human and civil rights issues that impact youth.
- Desire to be an active participant in all events, activities, and meetings sponsored by the Office of Human Rights and the Youth Human Rights Ambassador Program.
- Be a responsible leader and act with integrity throughout your term as a Youth Human Rights Ambassador.
- Be able to work well with others in a group.
- Willing to learn, grow, and share their knowledge and experience about human rights laws and processes in DC government.

Benefits:

- Elevate your resume by actively engaging in the development and execution of a variety of projects and outreach events.
- Opportunity to develop essential leadership skills in roles such as President, Vice President, Secretary, and more.
- Access to mentorship and educational opportunities provided by senior leadership at the Office of Human Rights, including, but not limited to: OHR Director, Associate Directors, Lawyers, Program Managers, and more.
- Recognition at the annual OHR and Commission Human Rights Awards Ceremony.
- Letter of recommendation from Office of Human Rights staff.

Application Process:

All applicants to the Youth Human Rights Ambassador Program must apply using the attached application. Application materials include:

- Completed application.
- Letter of Recommendation from a non-family member.
- Written Parental permission.
