#### I. CALL TO ORDER

a. Chairman Aizawa called the Commission's Official Meeting to order at 6:34 pm.

#### II. ROLL CALL

- b. A total of 10 commissioners appeared at the outset of the meeting. All were present via telecommunication. A quorum was present.

#### VI. REPORT OF THE DIRECTOR, OFFICE OF HUMAN RIGHTS

- a. OHR Director Hnin Khaing, gave the report, highlighting the following:
  - i. Budget: OHR is working on its FY24 budget.
  - ii. New Laws to Enforce: (1) Sexual Harassment Data Collection Act requires government agencies to submit data on the number of Sexual Harassment Complaints, how many are resolved, and other data on Sexual Harassment Complaints. (2) Domestic Workers Fairness Act, discussed in last commission meeting, which extends DCHRA protections to domestic workers, which went into effect October 1, 2023. We are having a training, hosted by DOES and the Domestic Workers Alliance Group, on December 13 at 7:00 PM for training on DWFA.

- iii. There will be a hearing on December 6 on the Fairness in Human Rights Act (B25-319), regarding provisions about attorneys' fees, dismissal, and withdraw cases, and overall changing the process.
- iv. OHR has a new IT Specialist to upgrade the Case Management System and work on other IT improvements.
- v. OHR asked everyone to please spread the word about Universal Paid Family Leave Act, which requires private employees to receive paid family leave in certain circumstances. It also protects private employees from retaliation on the basis of taking paid family leave.

#### VII. FY 2023 YEAR END CASE DATA & COMMISSION CASE INVENTORY: BRANDES ASH

- a. Judge Ash, in place of Chief Judge Pierson, gave the report on commissioner updates and case management.
- b. A PowerPoint presentation summarizes all the data for FY23.

a. Last week, Chair Aizawa received an award for Outstanding Advocacy by the Association for Ethnic Studies via Howard University. She mentioned that the award is in recognition of the work of the Commission as a whole.
